

## 2014-2015 School Year Immunization Law Minimum Dose Requirements

Doses documented on the immunization certificate must be valid doses according to accepted practice standards for the minimum age(s) and interval(s).

<sup>1</sup> CD (or Child Development) programs serving children in grades lower than 5K and within the school setting are regulated under the daycare law.

<sup>2</sup> A minimum of three (3) doses of any combination with at least one (1) dose on or after the fourth birthday is required for Grades 11-12. A minimum of four (4) doses of any combination with at least one (1) dose on or after the fourth birthday is required for 5K-10th grade. For unvaccinated or incompletely vaccinated children 7 years of age and older, refer to currently published ACIP Catch-Up Schedule for number of doses necessary to complete diphtheria, tetanus, and pertussis series and meet this requirement.

<sup>3</sup> One (1) dose received on or after the 7th birthday. Tdap is routinely administered at 11-12 years of age; however, if Tdap is needed at an earlier age, a dose administered on or after the seventh birthday will meet this requirement. *Please also encourage receipt of the following recommended adolescent and catch-up vaccines: meningococcal vaccine (MCV), Human Papillomavirus vaccine (HPV) and second dose of varicella vaccine.*

<sup>4</sup> A minimum of three (3) doses of any combination with at least one (1) dose on or after the fourth birthday is required for Grades 5K-2. \*Students in grades 3-12 are in compliance if: three (3) doses of OPV/IPV with one dose on or after the 4th birthday OR four (4) doses of IPV (all doses separated by at least 4 weeks) before the fourth birthday. Follow CDC recommendations for unvaccinated or incompletely vaccinated students 18 years of age and older.

<sup>5</sup> Dose one of Measles (Rubeola) vaccine must be received on or after the first birthday. Second dose must be separated from the first by at least one month.

<sup>6</sup> One dose of Rubella (German Measles) vaccine received on or after the first birthday.

<sup>7</sup> One dose of Mumps vaccine received on or after the first birthday.

<sup>8</sup> Two (2) doses of Varicella vaccine with both doses received on or after the first birthday or positive history of disease is required for 5K. Students in 1st-12th grades need (1) dose of Varicella vaccine received on or after the first birthday or positive history of disease. Minimum interval between dose #1 and #2: children <13 years of age separate by 12 weeks, children ≥ 13 years of age separate by 4 weeks.

<sup>9</sup> Current age-appropriate Hib vaccination. For children 15-59 months of age who have not yet completed age-appropriate Hib vaccination, one (1) dose of Haemophilus influenzae Type b vaccine at or after 15 months of age is required.

<sup>10</sup> Current age-appropriate PCV vaccination. For children aged 24-59 months who have not yet completed any age-appropriate pneumococcal vaccination schedule (PCV7 or PCV13), one (1) dose of 13-valent pneumococcal conjugate vaccine (PCV13) on or after the 2nd birthday is required. A single **supplemental** dose of PCV13 for children 14-59 months of age who have completed age-appropriate PCV7 vaccination is strongly recommended, but **not required** for daycare attendance.
